



Guidelines for Manuscript Presentation Format Manuscripts are to be prepared using a word processing package and saved in word doc formats. All manuscripts should be double-spaced and line numbers placed in the margin of 2.5 cm on all sides should be used. The organisation of the manuscript should follow guidance provided in the 'Article Types' section above. ORCID All authors submitting manuscripts to EHJ-Case Reports are expected to have obtained an ORCID. This can be obtained for free by visiting the ORCID website. This provides a unique persistent digital identifier that distinguishes individuals from other researchers and supports automated linkages to ensure that authors' work is recognised. Title page must include: (a) title, (b) name(s) of Author(s), (c) their institutional address, telephone number, and e-mail address, telephone number, and e-mail address. Figures Figures should be self-explanatory and contain as much information as is consistent with clarity. All figures must carry the figures must carry the figures is 300 dpi (dots per inch) for tone or colour, 1200 dpi for line art at approximately the correct size for publication. A scale should be included; otherwise the scale of the original should be stated in the legends so that the final scale can be calculated. Colour figures should be CMYK (Cyan-Magenta-Yellow-Black). For useful information on preparing your figures should be in lower case in both the figure and the legend. The journal reserves the right to reduce the size of illustrative material. All micrographs must carry a magnification bar. In the case of histology specimens, details of the staining technique and a scale bar should be provided Tables Tables and explanatory notes below. They should be included in the text file (either in the .PDF file for first submissions or in the Word file for accepted manuscripts). Slide Set containing details of the case as well as any figures or tables is submitted with the article. This can be provided at the time of the original submission or prepared once the article is provisionally accepted. The slide set will be reviewed by a supplementary materials editor and authors will be asked to incorporate any requested revisions. Note that the Slide Set should be no more than 10 slides long, 3-4 key learning points should be included, and no more than 5 references used. We recommend 3-5 bullet points per slide, each ~10 words long. Extensive prose should be avoided in the slide sets are cropped from larger images, it is the authors' responsibility to ensure that neither the cropped or original images contain patient identifiable information. Please add the case report manuscript number (i.e. EHJ-CR-...) to the 'article reference' box on all slides, including the title slide, and use UK rather than US spellings. Case Report and Grand Round articles will not be accepted until an acceptable Slide Set is provided. Videos EHJ-Case Reports considers that video can be an interesting and useful source of information for readers. Authors are encouraged to upload videos along with still figures with their case reports (and other article types). It is vital that any personally identifying elements from any video is removed by the authors prior to submission. A maximum of three videos will be displayed in-line with the article on the journal website. Additional videos will be available as supplementary materials for readers to download as required. Videos should be supplied in .mp4 format. The first three videos should be uploaded as 'inline videos' and not as supplementary materials. If more than three videos are included in a submission, subsequent videos should be uploaded as supplementary materials. Podcasting EHJ-Case Reports intends to create a podcast along with each issue of the journal.
